Call to Artists  
Fall 2006 Season - 2007 Season**

**The Exhibit:** Exhibits feature established and emerging artists working in two-dimensional media. Selected artists will each exhibit for approximately two - three weeks; the length of a Majestic Production show run. The Majestic Theatre Lobby Gallery is located at 281 Cartier St. Manchester. Artwork can be viewed during Majestic performances and during box office hours Tuesday - Friday 9am - 5pm.

**Eligibility:** The exhibit space is available to all professional and emerging artists working in all two-dimensional media. All works must be original. Each artist will be required to have a collection of works to fill the entire gallery space. If applying for a two-person show, each artist is required to have works to fill half of the gallery. Please note that The Majestic is a family theatre located in a church owned facility therefore, works must be appropriate for Majestic's family audiences. Exhibit space is in the theatre lobby along a black wall approximately 20 feet long and approximately 8 feet high.

**Jury:** Artist work samples will be juried by a select group of artisans and art professionals.

**Sales:** Works may be made available by the artist for sale in The Gallery. **A Commission of 10% will be taken on sales in the gallery during the exhibition.** In order to maintain the integrity of each exhibit, no pieces may be removed until the end of the exhibition period. The Majestic Theatre . The Majestic will accept cash, check or credit cards.

**Fees:** There is a \$25 application fee assessed for each exhibition in The Gallery.

You may choose to share your exhibition space with another selected artist. Please check the box on the application marked "Two Person Exhibition" if you are interested in this opportunity. Each artist must apply separately. Exhibiting artists will be chosen and paired by the jury.

**Accepted Artists:** The Majestic staff will schedule each artist's exhibition. Each artist is responsible for the installation and removal of his/her exhibit. All artists are expected to install properly framed artwork. Artwork not properly framed for exhibition will not be hung in The Gallery.

**Promotion by The Majestic Theatre:** Spotlight on [www.majestictheatre.net](http://www.majestictheatre.net), press release to media contacts, web postings, and inclusion in theatre playbill throughout the Majestic Season.

## Submission Guidelines/ Application

**Work samples:** Each artist must submit a minimum of five works for consideration. All submissions must be representative of work to be exhibited. All artist work proposed for exhibition will be reviewed by The Majestic prior to installation. Work Samples may be represented in the form of slides, electronic files or prints. Please include a self addressed stamped envelope for return of work samples. Samples can also be picked up at the Majestic Theatre box office.

**Resumé:** Submissions must include a brief biography or resumé.

**Application Fee:** There is a \$25.00, non-refundable application fee for each artist who wishes to be considered for exhibition.
